After Admission, the total number of Ordinary Shares in issue will be 47,692,093 and the total number of voting rights will therefore be 47,692,093. This figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the share capital of the Company under the FCA's Disclosure Guidance and Transparency Rules.
